### **START HERE:**

Thinking about interdiction? Louisiana requires a showing that you have tried less-restrictive ways to meet the needs of the person who may be interdicted. Start here to find alternatives to interdiction, and possibly solve your issues without going to court.

In Louisiana, when moving forward with interdiction the court will expect to see a genuine effort to seek alternative solutions first. The checklist may act as a guide to research options.

### **HOORAY – I'M THE CURATOR! NOW WHAT???**

When you are confirmed to act as the Curator for an interdict, what does that mean? What will you actually be doing in this new position? A Curator of the Person has duties that are distinct from the Curator of the Property of the interdict. Below are videos that discuss these matter in more detail.

## Overview of Curator's Duties

#### Video #2 Once you are appointed

Once the court has issued a judgement in favor of interdiction, and a curator is appointed, the next steps include Certified Letters, record keeping, financial responsibilities, visits, and the Annual Report to the court.

## **Duties of the Curator of the Person**

### Video #3 Duties Curator of the Person

This session will include information on communication with the interdict and their family, medical professionals/appointments, written plan of care, as well as communication with the undercurator, the courts and the Annual Report. It will also include reasons a curator may be removed.

## **Duties of the Curator of the Property**

#### Video #4 Duties of Curator of Property

The curator's fiduciary duty managing interdict's property may include possibly posting of a bond, the sale of a home or assets, record keeping for required for annual accounting, budgeting, and oversight by the undercurator.

## Will there be Paperwork?

#### Video #6 Reports to the Court

This session will comprehensively address the ANNUAL REPORT to the court with details on what must should be included (bank statements, major purchases, transferred assets, payment to the curator, etc.). It also discusses steps to take should the interdict regain capacity, and/or Final Reporting at the interdict's passing.
